as these signs fall off the fixtures they are attached to. This is important to ensure that Kingston is not plagued with such signs well into the future and that such unscrupulous people are deterred from reoffending within Kingston.

8. Question Time

1. David Nunns of Clayton South asked on behalf of the Australian Services Union (ASU),

"Why is there a practice at Kingston City Council where employees in the Home and Community Care area are short-changed on a regular basis and subjected to conditions of employment that are unacceptable to other parts of the operations of Kingston City Council?"

The CEO provided the following response,

"We are not aware this is the case. If the ASU believes this does happen, opportunities exist through the Employee Agreement process or by Fair Work Australia."

2. David Nunns of Clayton South asked on behalf of the Australian Services Union (ASU),

"Why do Kingston City Council continue to limit the rights of employees to dispute, challenge or appeal disciplinary action through the independent umpire (i.e. Fair Work Australia)?"

The CEO provided the following response,

"Council fully complies with the Fair Work Act."

3. David Nunns of Clayton South asked on behalf of the Australian Services Union (ASU),

"Is it possible for Kingston City Council to provide an update on the intake situation for residents that require Home and Community Care?"

The CEO provided the following response,

"Applications are made and received in accordance with the Commonwealth and State funding agreement and then are assessed in accordance with this agreement. There are no delays at all for residents with high needs."

4. Francine Gerraty of Heatherton asked,

"I am interested in why the proposed payment for the Green Wedge Plan prepared by Planishpere has not been refunded by the State Government and please state what the total cost to Kingston ratepayers has been so far. Is it above what is the expected total cost allocated for Green Wedge costs over the next Council financial year?"

The CEO provided the following response,

"There is no funding agreement with the State Government to fund the Kingston Green Wedge Plan. The cost was around \$400K and \$100K has been allocated in the 2012/13 Budget to progress the adopted Green Wedge Plan Initiatives."

5. Ian Baldock of Parkdale asked,

"I saw in tonight's agenda that Kingston City Council is discontinuing its membership with the Australian Mayoral Aviation Council. What is the reason behind the discontinuance of this previously successful membership and how will Kingston City Council continue to maintain inter-Council relationships for the benefit of its ratepayers in aviation related matters."

The CEO provided the following response,

"The focus of the Australian Mayoral Aviation Council is on national airports. For the cost of membership (approximately \$36K but not absolutely certain) there are no benefits provided to Kingston. All initiatives and lobbying on Moorabbin Airport have been by Kingston itself."

6. Vicki Stav of Beaumaris asked,

"Why are you trying to resend the motion regarding the Green Wedge, which was passed at the last meeting?"

The CEO provided the following response,

"This matter has been dealt with tonight and no changes were made to the previously adopted Council positions.

Section 11.4 now reads,

"There is no doubt that Crs West, Shewan and Staikos have at times been spirited in their debate on issues and in their disagreement with reports submitted and recommendations made to Council by (the senior officer). The input by other witnesses interviewed left a clear impression that Cr West, in particular, is at times very vigorous in pursuit of outcomes over Council issues of interest to her. However, robust discussion, spirited debate and the dogged pursuit of objectives are not synonymous with bullying behaviour or with breaches of the Councillor Code of Conduct. In fact it is probable that such pursuit of items of interest within the Council environment meets the expectations of the citizens who elect the Councillors into office."
