COMPULSORY DESEXING

All newly acquired dogs and cats living in Kingston and over the age of 3 months must be de-sexed prior to registration with the City of Kingston.

Exemptions include animals exempt under the *Domestic Animals Act 1994*, which are:

- a dog or cat owned by a person or body that conducts a domestic animal business registered with council, where the dog/cat is used for breeding purposes in connection with that business
- a dog or cat that is the subject of written veterinary advice that the health of the animal is liable to be significantly prejudiced if it is desexed. This written veterinary advice must be given by a veterinary practitioner after he or she has personally examined the dog or cat and must include the reasons why the health of the dog or cat is liable to be significantly prejudiced if it is desexed
- a dangerous dog kept for guarding non residential premises
- a dangerous dog that has undergone protection training
- a dog or cat that is owned by a person who is a current member of an Applicable Organisations and the animal is registered with that organisation (proof must be provided of both owners and dog/cat membership at the time of registration)
