## Monica Avenue, Bonbeach – Proposed change to parking conditions

### Background

Council is responding to community concerns regarding high levels of visitor parking on Monica Avenue in Bonbeach due to the area's proximity to the beach. To provide a balanced resolution for both residents and visitors, Council is proposing to make changes to the parking conditions on Monica Avenue.

### Council Action

Council seeks your opinion on the following change in Monica Avenue (see image over page for more details):

- Installation of '1 1/2P 9am-6pm' parking restriction on the north side of Monica Avenue.

**Please Note:** Residents living adjacent or opposite the restricted parking areas would be eligible for a residential parking permit to allow them to park within the restricted area.

Council's Parking Management Policy allows for 2 residential parking permits per dwelling. The permits cost \$50 per year, with the fee waived for the first permit. Due to the current COVID-19 pandemic, Council has placed a hold on fees for residential parking permits until 30 September 2020.

According to Council's Parking Management Policy, all dual-occupancy and sub-divided lots granted planning advertisement after 28th of July 2015 are not eligible for residential parking permits. These developments are expected to have on-site parking as required under the Kingston Planning Scheme. Alternatively, you are also able to visit us at 1230 Nepean Highway to lodge your application.
