## Fourth Lane, Chelsea Heights – Proposed speed humps

### Background

Council is responding to community concerns about the vehicle speeds and safety along Fourth Lane in Chelsea Heights, between Fourth Avenue and Fifth Avenue. Council has investigated these concerns and is proposing to change conditions in the lane.

### Council Action

Council is proposing to implement three speed humps along the length of the lane. Please see the attached plan for more information. The speed humps will help to manage vehicle speeds along the laneway, which will reduce the risks and improve safety.

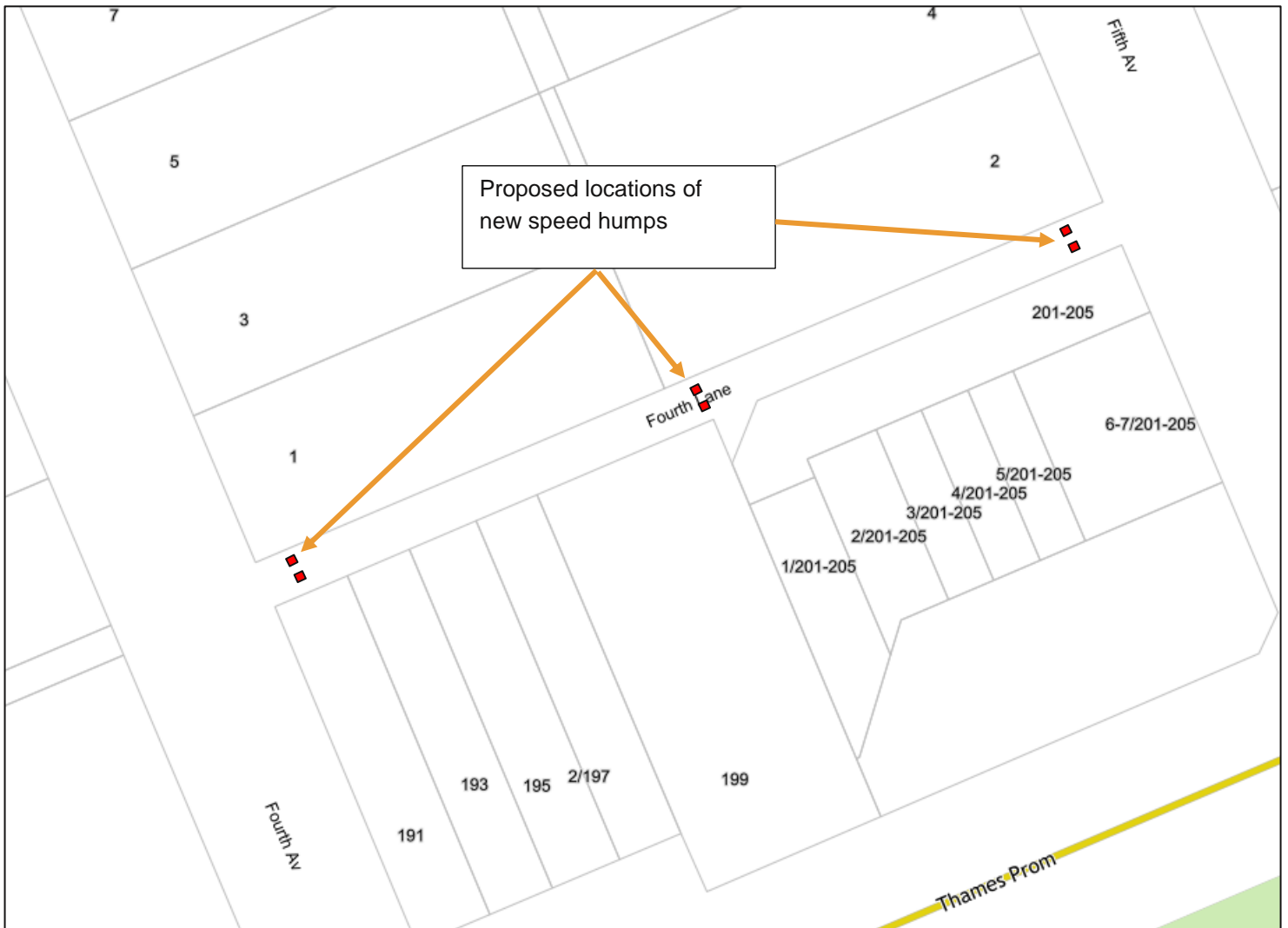
