Apply to Council to enter into a Payment Plan while the fine is still at the infringement stage with Council. **Or**,

At your request, Council can register your fine with Fines Victoria for a Payment Arrangement. A payment arrangement is managed by Fiens Victoria and can allow you to combine multiple types of fines into one payment arrangement. You can also pay by direct debit or Centrepay. This is not offered by Council.
