### Debbie of Heatherton asked,

"Why do our roads continue to remain rough, neglected, uneven surfaces, with some having dangerous potholes? Is Kingston Council responsible for this zone/electorate?"

### The Chief Executive Officer provided the following response,

"Local roads in Kingston are maintained in accordance with the levels of service in Kingston's Road Management Plan available on our website. Arterial roads are maintained by the Department of Transport and Planning. Road users are encouraged to bring to Council or to the Department's attention any specific defects which are considered dangerous, for repairs to be undertaken."

**Note:** A question submitted by Wandzia was not be read out and an answer not provided as, in accordance with the question was considered to be repetitive of a question, matter, issue or principle already answered.

### Rosemary West of Edithvale asked,

"Given that the Golf Course Redevelopment Strategic Advisory Committee recommended approving the rezoning of Kingswood golf course for residential development despite a very strong case against rezoning from Council and 8000 objectors including Mark Dreyfus KC MHR, why would Council think it can ask the Planning Minister to appoint a Golf Course Redevelopment Strategic Advisory Committee for Rossdale golf course and not expect the same outcome?"

### The General Manager Planning and Place provided the following response,

"The report presented as Item 8.6 on tonight's agenda provides guidance to the Council on the manner in which, the request made by the Rossdale Golf Course could be appropriately considered based on a range of 'threshold matters' relating to the subject land. The Executive Summary of the report prepared highlights a range of considerations that Officers considered previously to have not been addressed. Whether or not these matters could or even should be overcome, are considered issues that should be addressed first before any redevelopment proposal is put before the Council or the Planning Minister, for any further assessment."

The General Manager Planning and Place provided the following response, "The report presented as part of Item 8.1 on tonight's agenda highlights the significant additional work that has been done relating to Council's Urban Forest Strategy, Urban Cooling Strategy, Biodiversity Strategy and Council's recently adopted Planning Scheme Amendment C203 which includes Council's Landscape Guidelines that provide Officers with a range of methods to address replacement vegetation (trees, shrubs and ground cover) in a contemporary manner on development sites. The report also illustrates the extent to which Officers give consideration, to the nature of conditions applied to development applications to determine both the retention and replacement of appropriate vegetation based on the sites conditions and the development proposed."
